WE OFFERED 21 UNIQUE PROGRAMS, DIGITALLY AND IN-PERSON, INCLUDING SCHOLAR PANELS, CULTURAL HERITAGE WORKSHOPS, A PODCAST SERIES, AND A TRAVELING EXHIBIT. OUR PROGRAMS FOCUSED ON PRESERVING NATIVE AMERICAN, GERMAN, CIVIL WAR, AND RURAL CULTURAL HERITAGE.
